Horizonte 2020

- Programa de financiamento da investigación e innovación – case **80 mil millóns de euros** (2014 - 2020).
- Novo Programa Cadro (FP), que agrupa tres programas/iniciativas (FP, EIT, CIP).
- Continuación do apoio á **investigación** de calidad.
- Máis apoio para actividades de **innovación** – creación de **oportunidades de negocio**.
- **Simplificación** dos procesos e redución dos tempos.



Horizonte 2020

- **Novo regulamento de participación** más homoxéneo, coherente con outros programas da UE.
- **Un proxecto – unha porcentaxe** de financiamento.
 - Custos elixibles: directos + indirectos (25% dos custos directos).
 - Financiamento 100% para proxectos de investigación;
 - Financiamento 70 % para accións de innovación (100 % para entidades sen ánimo de lucro).
- Interese da **cooperación internacional**.
- **Criterios de avaliación**: Excelencia, Impacto, Implementación. Máximo 5 puntos por criterio.



Tipos de proxectos

Research & Innovation Actions (RIA)

Proyectos colaborativos transnacionales destinados a **generar nuevo conocimiento y/o explorar la viabilidad** de nuevas tecnologías, productos, procesos, servicios o soluciones.

Pueden **incluir actividades de investigación básica y aplicada**, desarrollo tecnológico e integración, así como testeo y validación mediante prototipos a pequeña escala en laboratorios o entornos simulados.

Innovation Actions (IA)

Proyectos colaborativos transnacionales destinados a elaborar planes, disposiciones y/o diseño para productos, procesos o servicios nuevos, modificados o mejorados.

Se incluyen actividades de **desarrollo de prototipos, ensayos, demostración, validación de producto a gran escala y de aplicación comercial**. **NO investigación básica**.

Coordination and Support Actions (CSA)

Medidas de acompañamiento para financiar actividades como estandarización, **difusión**, sensibilización y comunicación, **redes**, coordinación de servicios de apoyo, **diálogos políticos**, estudios y actividades de aprendizaje (training). **NO investigación**

Access to risk finance <i>Leveraging private finance and venture capital for research and innovation</i>	2.84
Innovation in SMEs <i>Fostering all forms of innovation in all types of SMEs</i>	0.6 complemented by c. 20% of societal challenges and industrial leadership


